

## THE HIGHLAND COUNCIL (AVIEMORE) (20 MPH SPEED LIMIT) ORDER 2022

NOTICE IS HEREBY GIVEN that The Highland Council proposes to make an Order in terms of Section 84 of the Road Traffic Regulation Act 1984 entitled as above.

If the Order comes into force, the Order will introduce a 20mph speed limit on the following roads in Aviemore over their entire length, unless stated otherwise below:
